REFERRAL FLOWCHART FOR ACTUAL OR SUSPECTED ABUSE -

CHILDREN (under 18 years of age)

Call 999 if a child is in immediate danger

NO – still follow the points in this box below - <u>Are they safe? Are you concerned?</u> YES – follow below
It is not your responsibility to decide if abuse has happened BUT

- ➤ It is your responsibility to report it to your **Designated Safeguarding Lead, (DSL) Andrew Ioannou or Deputy DSL Adrian McFarlane** and complete your safeguarding concerns form, detailing the concern/disclosure (in the child/YPs words, not your own), and sign, date and put the time of the form filling/disclosure received.
- > Then ensure your DSL also signs, dates and puts the time of receiving the written record on the form



What does the DSL now need to do if they believe there is a case of abuse or neglect?
